AGREEMENT FOR SUPPLY OF MATERIAL

The National Botanic Gardens, Glasnevin intends to honour the letter and spirit of the **1992 Convention On Biological Diversity (CBD)**, as well as the **Nagoya Protocol On Access To Genetic Resources** and the **EU Regulation No 511/2014** on compliance measures for the Nagoya Protocol in the use of its collections. In addition all seed has been assigned, or carries, an **International Plant Exchange Network (IPEN)** number which should be entered into the electronic register held by the recipient garden. Accordingly, the supply of material is subject to the following conditions:

1. Recipient may use the material and any progeny or derivatives thereof for non-commercial purposes only.
2. Recipient may not commercialise the material or any progeny or derivatives without obtaining written consent of NBG, Glasnevin, which will be consistent with NBG, Glasnevin's policy that benefits be shared equitably with the source country of the material.
3. Recipient will provide NBG, Glasnevin with a fair and equitable share of any benefits arising from the use of the material, including research results and publications.
4. Any publication should include the **IPEN** number in references to any cited material usage.
5. Recipient may not transfer the material to any third party without written agreement containing terms no less restrictive than those contained in this Agreement and on condition that the **IPEN** number accompanies all offspring.
6. Where IPEN numbers are provided these must be incorporated into the recipient's electronic database and be provided to third parties whenever material is accessed for research or publication purposes.

All distribution of plant material (including propagules) from the National Botanic Gardens of Ireland shall continue to be in accordance with the provisions of the **CBD**, the **Nagoya Protocol** and conform to the **IPEN's** Code of conduct in support of the **Global Strategy for Plant Conservation**.

- Every appropriate effort shall be made to include material of known and documented origins only, unless there is a specific reason for including undocumented material.
- No known invasive species shall be included in future seed lists.
- No material will be included in the Index Seminum that has been collected in the wild since 1992, in countries other than Ireland, unless specific permission to distribute such material has been given by the relevant authorities in the provider country.
